Management's Discussion and Analysis ("MD&A") is intended to help the reader understand Brixton Metal Corporation's (the "Company" or "Corporation") consolidated financial statements. The information provided herein should be read in conjunction with the audited consolidated financial statements for the years ended September 30, 2025 and 2024, which have been prepared in accordance with IFRS Accounting Standards ("IFRS") as issued by the International Accounting Standards Board. The following comments may contain management estimates of anticipated future trends, activities or results. Management is responsible for the preparation and integrity of the consolidated financial statements, including the maintenance of appropriate information systems, procedures and internal controls and to ensure that information used internally or disclosed externally, including the consolidated financial statements and MD&A, is complete and reliable. The Company's board of directors follows recommended corporate governance guidelines for public companies to ensure transparency and accountability to shareholders. The board's audit committee meets with management quarterly to review the consolidated financial statements including the MD&A and to discuss other financial, operating and internal control matters.

All currency amounts are in Canadian dollars unless otherwise noted.

Description of Business

The Company is an exploration stage company and engages principally in the exploration and development of mineral properties in Canada and the USA. Brixton became a public entity through a transaction whereby Marksmen Capital Inc. (a capital pool company trading on the TSX-V) acquired all of the issued and outstanding common shares of Brixton in exchange for the issuance of 1.8 common shares of Marksmen for each common share of Brixton. This transaction was completed on December 7, 2010, and constituted a reverse takeover transaction pursuant to the terms of the TSX-Venture Exchange.

- On November 22, 2024, the Company closed a previously announced non-brokered private placement for gross proceeds of \$5,983,797, issuing 66,486,631 flow-through units of the Company at a price of \$0.09 per unit, each unit consisting of one flow-through common share of the Company and one-half of one common share purchase warrant, each warrant exercisable at a price of \$0.12 per share for until November 22, 2026. In connection with the private placement, the Company paid finder's fees of \$300,390 and issued 2,462,666 finder's warrants exercisable at \$0.12 per share until November 22, 2026.
- On January 6, 2025, Ms. Christina Anstey departed the Company as Vice President, Exploration.
- On May 6, 2025, the Company announced the appointment of Michael Rapsch as Vice President, Investor Relations.
- On May 26, 2025, the Company granted 4,300,000 stock options to officers, directors, employees and consultants, exercisable at \$0.10 per share for a period of 10 years. The options are subject to a 12-month vesting period until May 26, 2026.

- On July 11, 2025, the Company closed a non-brokered flow-through private placement for gross proceeds of \$2,370,512, issuing 18,234,708 flow-through common shares of the Company at a price of \$0.13 per share. In connection with the private placement, the Company paid finder's fees of \$51,000 and issued 392,313 finder's warrants exercisable at \$0.13 per share until July 11, 2027.
- On July 24, 2025, the Company commenced drilling at the newly identified Catalyst Copper-Gold Porphyry Target at its wholly owned Thorn Project in northwest British Columbia. Please refer to 'Mineral Properties Overviews' for more details.
- On October 9, 2025, the Company received an option payment of \$250,000 from Eldorado Gold Corporation pursuant to the option agreement on the Company's Atlin project in British Columbia, Canada.
- On October 30, 2025, the Company announced the discovery of a new copper-gold porphyry system at the Catalyst Target at the Thorn Project. Please refer to 'Mineral Properties Overviews' for more details.
- In November 2025, an aggregate of 40,952,185 warrants with a weighted average exercise price of \$0.23 expired unexercised.
- On December 2, 2025, the Company closed the first tranche of a non-brokered private placement, which comprised 30,062,500 national flow-through units ("2025 NFT Units") of the Company at a price of \$0.08 per 2025 NFT unit, 37,761,989 critical minerals flow-through units ("2025 CMFT Unit") at a price of \$0.085 per 2025 CMFT Unit, and 1,192,857 traditional units ("2025 Units") at a price of \$0.07 per 2025 Unit, for total gross proceeds of \$5,698,269. Each of the 2025 NFT Units, 2025 CMFT Units, and 2025 Units each consisted of a national flow-through share, a critical mineral flow-through share, and a common share, respectively, and one common share purchase warrant, each warrant being exercisable at a price of \$0.10 per share for three years. In connection with the first tranche, the Company incurred finders' fees of \$88,246 and issued 1,051,481 finders' warrants exercisable at a price of \$0.10 per share for three years.
- On December 10, 2025, the Company received an advance of \$1,914,944 from Eldorado Gold Corporation towards exploration expenditures, pursuant to the option agreement on the Company's Atlin project in British Columbia, Canada.
- On December 11, 2025, the Company closed the second tranche of a non-brokered private placement, which comprised 250,000 2025 NFT Units at a price of \$0.08 per 2025 NFT Unit and 56,827,497 2025 Units at a price of \$0.07 per 2025 Unit, for total gross proceeds of \$3,997,925. In connection with the second tranche the Company incurred finders' fees of \$1,200 and issued 3,364,649 finders' warrants on the same terms as the first tranche finders' warrants.
- On December 18, 2025, the Company closed the third and final tranche of a non-brokered private placement, which comprised 35,714,285 2025 Units at price of \$0.07 per 2025 Unit for total gross proceeds of \$2,500,000.
- During the year ended September 30, 2025, an aggregate of 3,767,500 stock options with a weighted average exercise price of \$0.20 were expired or forfeited unexercised. A further

1,750,000 stock options with a weighted average exercise price of \$0.17 expired unexercised subsequent to September 30, 2025.

Results of Operations

Year ended September 30, 2025 compared with year ended September 30, 2024:

During the year ended September 30, 2025, the Company incurred a loss and comprehensive loss of \$8,069,566 (2024 - \$13,549,212) due to the following:

- Geological exploration costs were \$9,196,288 in the year ended September 30, 2025 (2024 - \$11,979,620) and included expenditures primarily on the Thorn project.
- Management fees of \$394,003 (2024 - \$761,134) were paid to the Chief Executive Officer and third-party consultants. The decrease was due to less consultants compared to the prior period.
- Investor relations expense was \$448,123 (2024 - \$345,177) and increased as a result of increased promotional activity compared to the prior period.
- Professional services were \$349,815 (2024 - \$412,183) and decreased due to less corporate activity compared to the prior period.
- Salaries and employee benefits of \$398,931 (2024 - \$595,056) and decreased due to a reduction in employees compared to the prior period.
- Share-based payments of \$85,918 (2024 - \$998,249) relating to the vesting of stock options granted to management, employees, directors, and consultants during the current and prior periods.
- Gain on excess carrying value of exploration and evaluation assets of \$710,350 (2024 - \$188,340) as a result of option payments received during the period on the Hog Heaven property.
- Interest income of \$417,487 (2024 - \$617,818) earned on short-term investments in the current period.
- Income tax expense of \$166,793 (2024 - \$96,397) in relation to United States federal and state taxes paid in the current period.
- Reduction of flow-through premium liability of \$2,591,200 (2024 - \$2,001,699) in relation to flow-through eligible expenditures incurred in the current period.

Three months ended September 30, 2025 compared with three months ended September 30, 2024:

The following analysis discusses the variations in the Company's quarterly results but, as with most junior mineral exploration companies, the results of operations (including net losses) are not the main factor in establishing the financial health of the Company. Of additional significance are the exploration and evaluation assets in which the Company has, or may earn an interest, its working capital and how many shares it has outstanding. The variations seen over the quarters are primarily a result of the level of activity of the Company's ongoing property evaluation program and the timing and results of the Company's exploration activities on its then-current properties. There are no general trends regarding the Company's quarterly results, and the Company's business of mineral exploration is semi-seasonal, as it can only work on the Thorn on a strict summer/fall basis,

however Langis can be explored throughout the year. Quarterly results can vary significantly depending on whether the Company has abandoned any properties or granted any stock options and these are the factors that account for material variations in the Company's quarterly net losses, none of which are predictable. The write-off of exploration and evaluation assets can have a material effect on quarterly results as and when they occur. The other major factor which can cause a material variation in net loss on a quarterly basis is the grant of stock options due to the resulting stock-based compensation charges which can be significant when they arise. General operating costs other than the specific items noted above tend to be quite similar from period to period.

During the three months ended September 30, 2025, the Company incurred a loss and comprehensive loss of \$4,433,861 (2024 - \$5,844,025) due to the following:

- Geological exploration costs were \$5,338,450 in the three months ended September 30, 2025 (2024 – \$6,583,097) and included expenditures primarily on the Thorn project.
- Management fees of \$108,502 (2024 - \$94,911) were paid to the Chief Executive Officer and third-party consultants. The increase was due to a slight increase in Chief Executive Officer, and an increase in consultants compared to the prior period.
- Investor relations expense was \$120,382 (2024 - \$94,911) and increased as a result of increased promotional activity compared to the prior period.
- Professional services were \$151,949 (2024 - \$136,684) and increased due to increased corporate activity compared to the prior period.
- Salaries and employee benefits of \$43,332 (2024 - \$120,993) and decreased due to a reduction in employees compared to the prior period.
- Share-based payments of \$48,987 (2024 - \$19,070) relating to the vesting of stock options granted to management, employees, directors, and consultants during the current and prior periods.
- Interest income of \$64,212 (2024 - \$135,696) earned on short-term investments in the current period.
- Reduction of flow-through premium liability of \$1,410,372 (2024 - \$1,467,917) in relation to flow-through eligible expenditures incurred in the current period.

Liquidity and Capital Resources

To date the Company has financed its operations through the sale of its common shares. As at September 30, 2025, the Company has \$5,363,481 in current assets and \$1,561,060 in current liabilities. The receivable balance is composed primarily of amounts receivable and tax credit refunds from the Government of Canada and Government of British Columbia.

The Company has no source of revenue, income or cash flow. It is wholly dependent upon raising funds through the sale of its common shares to finance its business operations. Over the next twelve months, the Company expects it will require additional capital to further develop and explore its Thorn, Langis, Atlin, and Hog Heaven projects and to cover general and administration costs.

On November 22, 2024, the Company closed a non-brokered private placement for gross proceeds of \$5,983,797. On May 27, 2025, the Company received \$635,000 as an advance on exploration expenditures on the Atlin project. On July 11, 2025, the Company completed an additional non-brokered private placement for gross proceeds of \$2,370,512. In December 2025, the Company completed an additional non-brokered private placement in three tranches for gross proceeds of \$12,196,194. On December 10, 2024, the Company also received \$1,919,944 as an advance on exploration expenditures on the Atlin project. The Company may also seek to raise additional funds through public or private equity funding, bank debt financing or from other sources to support ongoing property development. There can be no assurances that this capital will be available in amounts or on terms acceptable to the Company, or at all. These conditions are material uncertainties that cast significant doubt about the Company's ability to continue as a going concern.

The Company's cash position as at September 30, 2025 was \$3,848,109 (2024 - \$7,204,869). During the year ended September 30, 2025, operating activities required cash of \$11,160,728 (2024 - \$13,330,125).

The Company's investing activities required cash of \$42,532 (2024 - \$696,675 cash generated) during the year ended September 30, 2025, comprising \$712,698 (2024 - \$nil) in purchase of short-term investment, \$9,263 (2024 - \$84,175) in mineral property acquisition costs, \$24,000 (2024 - \$1,000) in reclamation bonds posted as restricted cash, and \$6,921 (2024 - \$nil) in purchases of equipment, offset by \$710,350 (2024 - \$781,850) received in mineral property option payments.

The Company's financing activities generated \$7,846,499 (2024 - \$14,305,210) during the year ended September 30, 2025, comprising \$8,354,309 (2024 - \$14,580,536) in proceeds from private placements, offset by \$456,537 (2024 - \$224,923) in share issuance costs and \$51,273 (2024 - \$50,403) in payments towards lease liabilities.

Use of Proceeds

Reconciliation of Use of Proceeds from Private Placements from fiscal 2012 to fiscal 2025

The Company has completed the following private placements:

- From April 2012 to September 2021, the Company raised an aggregate of \$46.4 million.
- In fiscal 2022, the Company raised an additional \$18.12 million.
- In fiscal 2023, the Company raised an additional \$14.6 million.
- In November 2023, the Company raised an additional \$14.58 million.
- In November 2024, the Company raised an additional \$6 million.
- In July 2025, the Company raised an additional \$2.3 million.
- In December 2025, the Company raised an additional \$12.2 million.

Mineral Properties Overview

Brixton Metals wholly owns four exploration projects in North America: 1) the Thorn Cu-Au-Ag-Mo Project located in Northwest British Columbia, Canada; 2) the Hog Heaven Ag-Cu-Au Project located in Northwest Montana, USA (Optioned by Ivanhoe Electric Inc. ("Ivanhoe Electric")); 3) the Langis-HudBay Ag-Co-Ni Projects located in Northeast Ontario, Canada; and 4) the Atlin Goldfields Project in Northwest British Columbia, Canada (optioned to Eldorado Gold Corporation). The Company's strategy is to systematically conduct high impact exploration to advance the projects toward a development decision and to monetize its non-core projects.

Thorn Cu-Au-Ag-Mo Project, British Columbia, Canada

The Thorn Project is fully permitted. The wholly-owned Thorn Project is a 2,945 square kilometer mineral claim group. The Thorn Project is located in northwestern British Columbia, Canada, approximately 90 km ENE from Juneau, Alaska. The Thorn Project is situated within the traditional territory of the Tahltan First Nation and Taku River Tlingit First Nation. The Company is committed to building long-term respectful relationships and joint business ventures with both First Nations within the region and is a firm supporter of the local economy.

The Thorn Project has been sporadically explored since 1951 by Cominco and 1959 by Kennco and many others since then. The Thorn Project represents an 80km mineralized mega-trend with many large scale copper-gold target areas identified. Geologically the project consists of Triassic to Eocene volcano-plutonic complex with many styles of mineralization related to porphyry and epithermal environments.

- Hole THN22-201 yielded 967.71m of 0.25% Cu, 0.09 g/t Au, 2.39 g/t Ag, 185.51 ppm Mo
 - Including 150.00m of 0.60% Cu, 0.19 g/t Au, 5.13 g/t Ag, 391.14 ppm Mo
- Hole THN23-285 at the Camp Creek Target intersected 717.00m of 0.20% Cu, 0.05 g/t Au, 1.92 g/t Ag, 458 ppm Mo
 - Including 248.05m of 0.37% Cu, 0.10 g/t Au, 3.32 g/t Ag, 255 ppm Mo

At surface, the Camp Creek area exhibits intense jarosite to acid sulphate alteration associated with high-sulfidation Ag-Cu-Au veins and breccias including a mineralized diatreme breccia. Drill hole THN11-60, which targeted the diatreme breccia returned 95.00m of 628.00 g/t Ag, 1.70 g/t Au, 0.12% Cu, 3.31% Pb and 2.39% Zn from 6.00m depth, including 9.25m of 2,984.00 g/t Ag, 3.04 g/t Au 0.53% Cu, 11.65% Pb and 3.42% Zn from 55.40m depth.

The Camp Creek porphyry-style mineralization starts at a depth of about 300m from surface and is considered a blind porphyry discovery. Calc-alkalic porphyry mineralization occurs in several geochemically distinct porphyry phases, as defined by UBC's Mineral Deposit Research Unit. The strongest mineralization occurs in Porphyry X, a crowded plagioclase porphyry of Cretaceous age, characterized by well-defined stacked biotite and is hosted in Triassic Stuhini Group sedimentary rocks, which are intruded by the porphyry phases.

The Trapper Gold Target

The Trapper Gold Target is located 6-10km southeast from the Camp Creek Target. Drilling encountered a broad zone of gold mineralization with significant visible gold believed to be structurally controlled along a faulted diorite porphyry and volcanoclastic contact. Drill hole THN21-186 returned 187.51m of 1.60 g/t Au from a downhole depth of 2.49m including 139.00m of 2.14 g/t Au including 11.00m of 19.25 g/t Au.

The Trapper Target is considered an epithermal gold target. The geochemical footprint for the Trapper Gold Target was expanded in 2021 to 4km by 1.5km in a northwest-southeast trend. Many surface rock grab samples have contained visible gold and returned assays up to 152.00 g/t Au. Gold mineralization occurs as several styles: within base metal-veins of sphalerite-galena-pyrite-chalcopyrite; hosted within quartz-stockwork veining; within sulphosalt-pyrite veinlets and as disseminations.

- Hole THN22-205 returned 64.00m of 5.74 g/t Au
 - Including 52.00m of 6.97 g/t Au
 - Including 28.95m of 10.36 g/t Au
- Hole THN22-237 returned 304.46m of 1.19 g/t Au

 - Including 93.00m of 3.22 g/t Au
 - Including 12.31m of 16.18 g/t Au

- Hole THN23-288 yielded 76.50m of 1.08 g/t Au,
 - Including 6.00m of 4.58 g/t Au

The Outlaw Gold Target

The Outlaw Zone is located about 3km south-southeast from the Camp Creek Target and represents a 5km east-west trending gold-in-soil anomaly hosted in clastic sediments where mineralization is thought to be related to Jurassic age felsic dykes.

- Central Outlaw hole THN14-128 returned 59.65m of 1.15 g/t Au and 5.64 g/t Ag.

2024 and 2025 Highlights from the Thorn Project

On May 24, 2024, Brixton announced that it had commenced its fully-funded 2024 drill season at its Thorn Copper-Gold Porphyry Project in the amount of \$12.5 million.

On June 20, 2024, Brixton announced that it has entered into a Royalty Purchase Agreement dated June 17, 2024 with Kohima Pacific Gold Corporation (“Kohima”), a private company, pursuant to which the Company will purchase and concurrently cancel, the outstanding 2% royalty on net smelter returns from the Check-Mate claim and the outstanding 3.5% royalty on net smelter returns from the Stuart claims, all of which are located on the Company’s Thorn Project centered around the Camp Creek Target. The Company agreed to issue an aggregate of 2,500,000 common shares to Kohima in consideration for the purchase and cancellation of the net smelter return royalties all as set out in the Royalty Purchase Agreement.

From June 5th to July 3rd, 2024 Brixton completed a 103 square kilometer MT Geophysics Survey over the North and Cirque Targets on the Thorn Property.

On July 25, 2024 Brixton announced its first drill results of the 2024 season with 1467.73m of copper-gold-silver-molybdenum with several sub-intervals at the Camp Creek Target as highlighted below:

- Copper dominant porphyry mineralization starts at 314.5m depth in hole THN24-290 which ended in mineralization at 1564m depth and remains open in all directions
- Important higher-grade sub-intervals yield broad zones of Cu-Au-Ag-Mo mineralization:
 - 960.40m of 0.21% Cu, 0.06 g/t Au, 2.71 g/t Ag, 279 ppm Mo

Hole THN24-290 significantly increases the volume of mineralized porphyry at Camp Creek.

On August 6, 2024, Brixton announced its second drill hole results of the 2024 season from the Camp Creek Target with highlights as follows from hole THN24-291:

- A gold dominant zone identified above porphyry-copper mineralization from 116.50-178.00m represents a potential southwest extension to the high-sulphidation gold system of the Talisker Zone to a 900m strike length yielding:
 - 61.50m of 0.89 g/t Au, 10.5 g/t Ag, 0.13% Cu
 - Including 37.30m of 1.35 g/t Au, 16.1 g/t Ag, 0.21% Cu
 - Including 11.00m of 3.53 g/t Au, 43.7 g/t Ag, 0.67% Cu
 - Including 4.65m of 6.15 g/t Au, 61.9 g/t Ag, 0.96% Cu

Copper-dominant porphyry mineralization within THN24-291 begins at 397.95m depth and ended in mineralization at 1524m with increasing copper grades observed over the bottom 25m.

Hole THN24-291 intercepted broad zones of Cu-Au-Ag-Mo mineralization with several sub-intervals as follows:

- 1126.05m of 0.18% Cu, 0.05 g/t Au, 1.82 g/t Ag, 167 ppm Mo
- 575.50m of 0.27% Cu, 0.06 g/t Au, 2.32 g/t Ag, 266 ppm Mo
- 55.94 of 0.44% Cu, 0.13 g/t Au, 3.60 g/t Ag, 253 ppm Mo

Hole THN24-291 significantly extends the footprint of mineralized porphyry at Camp Creek towards the northwest.

On September 10, 2024, Brixton announced that it had acquired a one hundred percent interest in mineral claims totaling 6446 hectares or 64.4 square kilometers within the Thorn Project, not previously controlled, located north and northwest from the past producing Golden Bear Mine.

On October 10, 2024, Brixton announced drill results from the Trapper Gold Targets as follows:

- Hole THN24-300 yielded 254.00m of 0.48 g/t Au from 6.00m depth, including 171.00m of 0.63 g/t Au, including 41.00m of 1.08 g/t Au, including 6.00m of 4.19 g/t Au, 22.07 g/t Ag.

On November 19, 2024, Brixton announced Trapper drill results from hole THN24-311 that yielded 48.50m of 1.16 g/t gold from 73.00m depth, including 20.00m of 2.34 g/t gold, including 3.00m of 5.67 g/t gold.

On December 9, 2024, Brixton announced further Camp Creek drill results:

- Hole THN24-307 intercepted a gold dominant zone of high-sulphidation mineralization, returning 114.50m of 0.53 g/t Au and 20.1 g/t Ag from 83.5m depth including 26.00m of 1.89 g/t Au, 74.8 g/t Ag, 0.28% Cu from 172m depth including 8.00m of 4.52 g/t Au, 148.6 g/t Ag, 0.54% Cu.
- Hole THN24-307 intercepted broad zones of Cu-Au-Ag-Mo mineralization which yielded 647.83m of 0.26% Cu, 0.11 g/t Au, 2.70 g/t Ag, 274 ppm Mo (0.49% CuEq), including 261.72m of 0.35% Cu, 0.17 g/t Au, 3.26 g/t Ag, 242 ppm Mo (0.61% CuEq), including 50.00m of 0.54% Cu, 0.58 g/t Au, 5.33 g/t Ag, 176 ppm Mo (1.07% CuEq).

On January 14, 2025, Brixton announced that it had identified several new porphyry targets from its 2024 Regional Prospecting Program, including the following highlights:

- Discovery of two new porphyry targets on trend along the Camp Creek corridor. The larger of the two zones is called Catalyst and Tempest which are located 6-8km from the Camp Creek porphyry. Rock grab samples of porphyry style stockwork veins from Catalyst returned up to 0.56% Cu, 2.87 g/t Au, 30.0 g/t Ag and 0.11% Mo.
- Porphyry style stockwork vein mineralization over a 3km by 1.5km area was identified at the Sentinel Target. Rock sampling from the main Sentinel area generated results of up to 1.54% Cu, 0.54% Mo, 0.2 g/t Au and 21.7 g/t Ag.

On July 22, 2025, Brixton announced its first batch of drill results from 2025 with highlights below:

- Hole THN25-318 cut 1.5m of 9.5 g/t gold, 13.8% copper, 771.5 g/t silver, 7.6% lead, 609.50 g/t tellurium, 7.1% zinc from 165.5m depth

On July 29, 2025, Brixton announced its second batch of drill results from the Glenfiddich Zone, in the Camp Creek area with the following highlights:

On August 19, 2025, Brixton announced that it had drilled 28.35m of 1.63 g/t of gold, 76.79 g/t silver, 0.61% copper and 1002 g/t antimony at the Northside Vein, Camp Creek Area.

On September 10, 2025, Brixton announced that it had drilled 29m of 1.75 g/t gold including 7.5m of 3 g/t Gold at its Trapper Gold Target.

On October 01, 2025, Brixton announced that it had drilled 15m of 2.26 g/t gold and 6.4m of 4.61 g/t gold including 14.3 g/t gold over 1.5m at the Trapper Gold Target.

On October 07, 2025, Brixton announced that it had drilled 38.50m of 4.07 g/t gold from 191.00m depth including, 1.85m of 39.61 g/t gold at the Trapper Gold Target.

On October 15, 2025, Brixton announced that it had drilled 22.15m of 4.44 g/t gold from 203.85m depth including, 1.50m of 57.20 g/t gold at the Trapper Gold Target.

On October 30, 2025, Brixton announced that it had made a new copper-gold porphyry discovery at the Catalyst Target where it drilled 424m of 0.12 g/t Au, 0.12% Cu, 2.96 g/t Ag, 51ppm Mo from 9m depth, including 16.50m of 0.17 g/t Au, 0.22% Cu, 59 g/t Ag, 32 ppm Mo. The target surface expression was expanded to a copper in-soils geochemical anomaly of 3 square-km area and an IP chargeability high geophysical anomaly of 1.35 square-km.

On November 12, 2025, Brixton announced that it had drilled 112 g/t Gold Over 0.50m with visible gold within 23.50m of 3.33 g/t gold at Trapper Target and 18.50m of 3.39 g/t gold, including 3.00m of 15.69 g/t gold.

On December 1, 2025, Brixton announced that it had made a new copper-gold porphyry discovery at the Tempest Target where it had drilled 90m of 0.17 g/t Au, 0.12% Cu, 1.28 g/t Ag, 42 ppm Mo including 16.55m of 0.37 g/t Au, 0.22% Cu, 1.13 g/t Ag, 72 ppm Mo. Tempest is located 2km south of the newly discovered Catalyst Target and has a 1.95 square-km IP chargeability high geophysical anomaly.

On December 16, 2025, Brixton announced that it had drilled 3.00m of 4.27 g/t gold and 11.63 g/t silver from 51.70m depth and 1.20m of 11.45 g/t gold and 9.21 g/t silver from 119m depth at its Trapper Target.

The Thorn Project is fully permitted for drilling. The Company is targeting 10,000-15,000m of drilling for 2026 but has yet to finalize a budget. The focus is on high-impact drill targets for copper and gold with a short-term goal of achieving the Mineral Resource Estimate stage.

The Hog Heaven Ag-Au-Cu Project

The wholly owned Hog Heaven Project consists of approximately 10 sections of private lands. The project is located in Northwest Montana, USA, with good road access and nearby under-utilized mills. The Hog Heaven Project is a high-sulphidation epithermal silver-gold-copper-lead-zinc deposit with historical production with porphyry potential. The Hog Heaven mine produced from 1928 – 1975 about 6.7Moz Ag at an average grade of 29 troy ounces of Ag per ton, 3,000 oz Au, 23M lbs Pb, 0.6M lbs Cu from 230,000 tons and an additional 49,700 tons grading 9.35 troy ounces of Ag per ton. The ore was shipped directly to smelters. Assays have returned up 3000 opt Ag from underground workings from historic operations. Coca Mines produced a positive feasibility study in 1988 and received State approval to build a mine until the gold and silver prices dropped in 1990 and the development plans stalled.

On March 2, 2021, Brixton announced the signing of a US\$44.5 million (US\$4.5 million in cash to Brixton and US\$40 million in exploration expenditures) definitive earn-in agreement (“Earn-in Agreement”) with a wholly owned Montana subsidiary of High Power Exploration Inc. (“HPX”), a privately-owned mineral exploration and development company led by Chairman and CEO, Robert Friedland (see October 27, 2020 news release). The Earn-in Agreement provides HPX (now IE Montana Holdings Ltd. (“IEM”)) with an Option to earn-in up to 75% interest in the project over 11 years. IEM is a wholly owned subsidiary of Ivanhoe Electric, which is the operator of the project.

Drilling Highlights

From 2020-2023, Brixton’s drill hole HH20-02 intersected a broad 224.85m zone of mineralization for 78.16 g/t Ag, 0.66 g/t Au, 0.24% Cu (75.07m-299.92m) which includes the following:

- 5.48m of 445.79 g/t Ag, 1.41 g/t Au, 1.50% Cu
- 2.13m Of 917.36 g/t Ag, 2.00 g/t Au, 3.06% Cu
- Exploration drill hole HHD-005 intersected 311 meters containing 0.35 g/t gold, 22.89 g/t silver, 0.36% lead, and 0.55% zinc, from 162 to 473 meters.

On February 5, 2024, Ivanhoe Electric announced drill results as follows:

- Drilling results to date expand high-sulphidation mineralization and provide evidence to support the existence of a porphyry deposit at the Hog Heaven Project.
- Drill hole HHD-007 intersected 348 meters containing 0.43 g/t gold, 40.48 g/t silver, 0.22% lead, and 0.12% zinc, from 141 to 489 meters, including 1 meter of 2,180 g/t silver, 5.16 g/t gold, 6.00% lead, 6.14% zinc and 0.63% copper from 147.8 to 148.8 meters.
- Hole HHD-009 returned 145 meters of 0.26 g/t gold, 27.47 g/t silver and 0.20% copper, including 0.95 meters of 5.39 g/t gold, 524 g/t silver and 7.99% copper.

As of April 30, 2024, a total of 15,595 meters in 17 drill holes have been completed. Results are pending for Ivanhoe Electric’s Typhoon geophysical survey on the project. Porphyry-style quartz stockwork veining observed in numerous clast fragments entrained within a late intrusion provides additional evidence for a porphyry system.

On April 2, 2024, Ivanhoe Electric announced the best copper-gold-silver intersection to date from the Hog Heaven Project:

- Drill hole HHD-014 intersected 82 meters containing 0.63% copper, 0.32 g/t gold, and 37.8 g/t silver from 568 meters depth, including a high-grade vein zone of 3.95 meters of 5.78% Copper, 2.2 g/t Gold and 264.7 g/t Silver

On January 6, 2025, Ivanhoe Electric announced a summary of recent results from the Hog Heaven Project. Initial drilling at the Battle Butte Area, HHD-017 through to HHD-022, has intersected a porphyry copper-gold-molybdenum system (“Battle Butte Porphyry”) associated with a large, 1,500 meters by 1,000 meters Typhoon™ conductivity anomaly at 1,200 meters depth. Mineralization is related to a series of variably mineralized and altered porphyry intrusives and hydrothermal breccias hosting gold-bearing copper, iron, and molybdenum sulphides as breccia matrix, sheeted to stockwork veining and as disseminations.

- Hole HHD-018: returned 286.0m of 0.14% copper, 0.14 g/t gold, 0.01% molybdenum, and 1.70 g/t of silver from 947.0m depth, including 97.9m of 0.21% copper, 0.20 g/t gold, 0.01% molybdenum and 2.79 g/t silver from 947.0m.
- Hole HHD-019 returned 680.0m of 0.09% copper, 0.06 g/t gold, 0.02% molybdenum, and 0.96 g/t silver from 1,172.0m depth.

Current evidence suggests that the Battle Butte Porphyry system is open to the east and north, where the Typhoon™ anomaly remains untested at depth.

The 2026 exploration plan under Ivanhoe Electric is to drill 3 to 5 deep holes to test for porphyry potential across the Hog Heaven Project.

Langis and HudBay Silver-Cobalt-Nickel Properties, Ontario, Canada

The projects are located within the historic silver-cobalt mining camp, including two past producers. The projects are located approximately 500 km north of Toronto, Canada. The Cobalt Silber mining camp has historically produced over 500 million ounces of silver and 50 million pounds of cobalt. At Langis, silver recovery ranged from 88% to 94% based on historical records. Excellent local infrastructure: year-round road access, close proximity to power, railway and gas-pipeline and a new cobalt refiner was established by Electra Battery Materials. Past production at the Langis mine was 10.4 million ounces of silver and 358,340 pounds of cobalt. The silver head grade was approximately 25 oz/t (777.60 g/t). Past production at the HudBay mine produced a total of 6.4M ounces of silver at 123 oz/ton Ag and 185,570 pounds of cobalt.

An Exploration Agreement was signed with the Timiskaming First Nation and Brixton in 2016.

The only drilling by Brixton at the Hudbay Project was in 2018, which returned highlights:

- HB18-31 yielded 2.00m of 1,667.30 g/t silver from 22.00m depth.
- HB18-26 intersected 4.00m of 536.50 g/t silver from 45.00m depth.

Highlights from 2016-2022 at the Langis Project

Previous drilling by Brixton has yielded 15 intercepts greater than 1000 g/t Ag, including 3 intercepts greater than 5000 g/t Ag in the Shaft 3 area; 10 intercepts greater than 1000 g/t Ag and 5 intercepts greater than 5000 g/t Ag in the Shaft 6 area;

No work was conducted on the project during 2023-2025. On January 13, 2026, Brixton announced that it has started a 10,000-15,000m phase one drill program at its Langis Silver Project with the objective of laying the groundwork for a maiden Mineral Resource Estimate.

The Atlin Goldfields Project

Brixton holds approximately 581 square kilometers of mineral rights in the Atlin Mining District of Northwest British Columbia. The project is located east of the town of Atlin and is road accessible with a well-established network of roads and is amenable to year-round drilling. Placer gold mining operations have been active in the Atlin Goldfield for the past 120 years.

Brixton's objective for this project is to locate the hard rock source of the placer gold. The deposit type for the Atlin Goldfields Project is considered orogenic gold and intrusion related gold.

The Yellowjacket Target within the Atlin Goldfields Project is a permitted 200 tonnes per day mine on care and maintenance. Drilling at Yellowjacket Target has been shallow with an average drill length of 84m. The Yellowjacket Target is road accessible and located 9 kilometers from the town of Atlin. Previous drilling identified high-grade gold mineralization including:

- YJ03-01 of 5.57m of 509.96 g/t Au.
- TW05-02 of 13.50m of 11.21 g/t Au.
- MET06-02 of 3.00m of 111.41 g/t Au.

The Imperial Mine dating back to 1899 is approximately 3 kilometers northwest of the Yellowjacket Target. Historic records indicate that 268 tonnes were mined at a grade of 11.5 g/t Au, Minfile 104N 008. The LD Showing has assayed up to 293 g/t Au.

On May 6, 2022, and subsequently amended on May 10, 2022, July 11, 2022, July 29, 2022, and May 4, 2023, Brixton entered into a definitive agreement with Pacific Bay, whereby Pacific Bay could have acquired a 100% interest in the Atlin Goldfields Project.

On December 12, 2022, Pacific Bay announced results from its first 2 drill holes at the Atlin Goldfields Project. Diamond drill hole YJ22-01 intersected the Yellowjacket main zone returning 9.96 g/t gold over 3.05m from 117.96m depth.

On August 10, 2023, Brixton terminated the option and earn-in joint venture agreement with Pacific Bay with respect to the Atlin Goldfields Project, as Pacific Bay did not meet its obligations under the definitive agreement within the prescribed time periods.

During September 2023, Brixton drilled one HQ-sized core hole to total depth of 349.91m at the Yellowjacket Target. Hole YJ-23-003 yielded 35.00m of 0.77 g/t Au, including 19.00m of 1.34 g/t Au, including 0.45m of 38.1 g/t Au with visible gold.

On July 16, 2024, Brixton announced that it had entered into a definitive option agreement with Eldorado (as defined herein), whereby Eldorado had been granted the option to acquire 100%-ownership of the Company's Atlin Goldfields Project.

During 2024 and 2025, Eldorado conducted geological mapping, geophysical surveys, and geochemical work in preparation for drilling in 2026. Eldorado has approved a \$1.91 million budget for 2026 exploration at the Atlin Goldfields Project which shall include mostly drilling.

Qualified Person

Mr. Gary R. Thompson, P.Geo., President, Chairman and CEO of the Company is a Qualified Person as defined under National Instrument 43-101 standards and has reviewed the technical information and approved this summary of results.

Environmental, Social and Governance

During 2022, Brixton initiated an internal Environmental, Social and Governance ("ESG") review. The purpose of this review was to collect the Company's ESG information and data, identify risks, review existing risk mitigation plans, and analyze potential gaps and opportunities. Brixton commits to develop an ESG strategy that aligns with early-stage mineral exploration, establish consistent and controlled ESG policies, and engage all stakeholders to pursue a sustainable growth profile.

2024 ESG Highlights

In the 2024 Thorn field season, Brixton's continued use of fuel bladder systems and basing a plane at the Atlin Airstrip resulted in 86 fewer flights, reducing travel by 17,075 km and eliminating the need for 1,986 forty-five-gallon fuel drums. These efficiencies significantly reduced the risk of fuel spills, lowered the project's carbon footprint, and achieved a combined cost savings of \$696,812 in flight and drum expenses.

- 45% of Brixton Metals personnel worked for First Nation contractors or Joint Ventures.
- First Nations employees, contractors, and management accounted for 22% of the seasonal workforce.
- Female employees, contractors, and management accounted for 24% of the seasonal and full-time workforce.
- 28.57% of Brixton Metals contracts are with First Nation joint ventures or direct partnerships.

2025 ESG Highlights

In the 2025 Thorn field season, Brixton's continued use of fuel bladder systems resulted in 57 fewer flights, reducing travel by 16,758 km and eliminating the need for 795 forty-five-gallon fuel drums.

These efficiencies significantly reduced the risk of fuel spills, lowered the project's carbon footprint, and achieved a combined cost savings of \$353,925 in flight and drum expenses.

- 31% of Brixton Metals personnel worked for First Nation contractors or Joint Ventures.
- First Nations employees, contractors, and management accounted for 19% of the seasonal workforce.
- Female employees, contractors, and management accounted for 30% of the seasonal and full-time workforce.
- 25% of Brixton Metals contracts are with First Nation joint ventures or direct partnerships.

Risk Factors

The Company is in the business of acquiring, exploring and, if warranted, developing and exploiting natural resource properties, currently in British Columbia. Due to the nature of the Company's proposed business and the present stage of exploration of its mineral properties (which are primarily early-stage exploration properties with no known resources or reserves), the following risk factors, among others, may apply:

Resource Exploration and Development is Generally a Speculative Business: Resource exploration and development is a speculative business and involves a high degree of risk, including, among other things, unprofitable efforts resulting not only from the failure to discover mineral deposits but from finding mineral deposits which, though present, are insufficient in size to return a profit from production. The marketability of natural resources that may be acquired or discovered by the Company will be affected by numerous factors beyond the control of the Company. These factors include market fluctuations, the proximity and capacity of natural resource markets, government regulations, including regulations relating to prices, taxes, royalties, land use, importing and exporting of minerals and environmental protection. The exact effect of these factors cannot be accurately predicted, but the combination of these factors may result in the Company not receiving an adequate return on invested capital. **The vast majority of exploration projects do not result in the discovery of commercially mineable deposits of ore.** Substantial expenditures are required to establish ore reserves through drilling and metallurgical and other testing techniques, determine metal content and metallurgical recovery processes to extract metal from the ore, and construct, renovate or expand mining and processing facilities. No assurance can be given that any level of recovery of ore reserves will be realized or that any identified mineral deposit, even if it is established to contain an estimated resource, will ever qualify as a commercial mineable ore body which can be legally and economically exploited. The great majority of exploration projects do not result in the discovery of commercially mineable deposits of ore.

Fluctuation of Metal Prices: Even if commercial quantities of mineral deposits are discovered by the Company, there is no guarantee that a profitable market will exist for the sale of the metals produced. Factors beyond the control of the Company may affect the marketability of any substances discovered. The prices of various metals have experienced significant movement over short periods of time, and are affected by numerous factors beyond the control of the Company, including international economic and political trends, expectations of inflation, currency exchange fluctuations, interest rates and global or regional consumption patterns, speculative activities and increased production due to improved mining and production methods. The supply of and demand for metals are affected by various factors, including political events, economic conditions and production costs in major producing regions. There can be no assurance that the price of any commodities will be such that any of the properties in which the Company has, or has the right to acquire, an interest may be mined at a profit.

Share Price Volatility: During the past year, exploration or development stage companies have experienced unprecedented volatility in price which have not necessarily been related to the operating performance, underlying asset values or prospects of such companies. Consequently, despite the Company's past success in securing significant equity financing, market forces may render it difficult or impossible for the Company to secure places to purchase new share issues at a price which will not lead to severe dilution to existing shareholders, or at all. Therefore, there can be no assurance that significant fluctuations in the trading price of the Company's common shares will not occur, or that such fluctuations will not materially adversely impact on the Company's ability to raise equity funding without significant dilution to its existing shareholders, or at all.

Financing Risks: The Company has limited financial resources, has no source of operating cash flow and has no assurance that additional funding will be available to it for further exploration and development of its projects or to fulfill its obligations under any applicable agreements. Although the Company has been successful in the past in obtaining financing through the sale of equity securities, there can be no assurance that it will be able to obtain adequate financing in the future or that the terms of such financing will be favorable. Failure to obtain such additional financing could result in delay or indefinite postponement of further exploration and development of its projects with the possible loss of such properties.

Insufficient Financial Resources: The Company does not presently have sufficient financial resources to undertake by itself the acquisition, exploration, and development of all of its planned acquisition, exploration and development programs. Future property acquisitions and the development of the Company's properties will therefore depend upon the Company's ability to obtain financing through the joint venturing of projects, private placement financing, public financing, short- or long-term borrowings or other means. There is no assurance that the Company will be successful in obtaining the required financing. Failure to raise the required funds could result in the Company losing, or being required to dispose of, its interest in its properties.

Dilution to the Company's existing shareholders: The Company will require additional equity financing to be raised in the future. The Company may issue securities at less than favorable terms to raise sufficient capital to fund its business plan. Any transaction involving the issuance of equity securities or securities convertible into common shares would result in dilution, possibly substantial, to present and prospective holders of common shares.

Increased costs: Management anticipates that costs at the Company's projects will frequently be subject to variation from one year to the next due to several factors, such as the results of ongoing exploration activities (positive or negative), changes in the nature of mineralization encountered, and revisions to exploration programs, if any, in response to the foregoing. In addition, exploration program costs are affected by the price of commodities such as fuel, rubber and electricity and the availability (or otherwise) of consultants and drilling contractors. Increases in the prices of such commodities or a scarcity of consultants or drilling contractors could render the costs of exploration programs to increase significantly over those budgeted. A material increase in costs for any significant exploration programs could have a significant effect on the Company's operating funds and ability to continue its planned exploration programs.

Mining Industry is Intensely Competitive: The Company's business of the acquisition, exploration and development of mineral properties is intensely competitive. The Company may be at a competitive disadvantage in acquiring additional mining properties because it must compete with other individuals and companies, many of which have greater financial resources, operational experience and technical capabilities than the Company. Increased competition could adversely affect the Company's ability to attract necessary capital funding or acquire suitable producing properties or prospects for mineral exploration in the future.

Permits and Licenses: The operations of the Company will require licenses and permits from various governmental authorities. There can be no assurance that the Company will be able to obtain all necessary licenses and permits that may be required to carry out exploration, development and mining operations at its projects, on reasonable terms or at all. Delays or a failure to obtain such licenses and permits, or a failure to comply with the terms of any such licenses and permits that the Company does obtain could have a material adverse effect on the Company.

Government Regulation: Any exploration, development or mining operations carried on by the Company, will be subject to government legislation, policies and controls relating to prospecting, development, production, environmental protection, mining taxes and labour standards. In addition, the profitability of any mining prospect is affected by the market for precious and/or base metals which is influenced by many factors including changing production costs, the supply and demand for metals, the rate of inflation, the inventory of metal producing corporations, the political environment and changes in international investment patterns.

Environmental Restrictions: The activities of the Company are subject to environmental regulations promulgated by government agencies in different countries from time to time. Environmental legislation generally provides for restrictions and prohibitions on spills, releases or emissions into the air, discharges into water, management of waste, management of hazardous substances, protection of natural resources, antiquities and endangered species and reclamation of lands disturbed by mining operations. Certain types of operations require the submission and approval of environmental impact assessments. Environmental legislation is evolving in a manner which means stricter standards, and enforcement. Fines and penalties for non-compliance are more stringent. Environmental assessments of proposed projects carry a heightened degree of responsibility for companies and directors, officers and employees. The cost of compliance with changes in governmental regulations has a potential to reduce the profitability of operations.

Indigenous Claims: The Company operates and conducts exploration on properties which are subject to Indigenous traditional rights and treaties. In particular, the Company's Thorn Property lies within the Traditional Territories of the Taku River Tlingit and Tahltan first nations. The Company is committed to engaging with the appropriate Indigenous groups about any potential impact of its activities on such rights, which may result in delays or suspensions of exploration or mining activities.

In addition, the Government of British Columbia has recently introduced legislation to implement the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) in British Columbia. The legislation commits to a systematic review of the province's laws with respect to UNDRIP, while also encouraging new agreements with Indigenous nations that are intended to address outstanding governance questions around the nature of Indigenous rights and title interests in British Columbia. While the potential risks of this legislation remain to be determined, they could be significant, particularly with respect to Brixton's permitting efforts.

In June 2025, the Government of British Columbia in partnership with Tahltan First Nation and Taku River Tlingit First Nation initiated a Land Use Planning Process within a large area of northwest British Columbia. The mineral claims that the Company holds in this area are largely in an overlap of traditional territory claimed by both Tahltan First Nation and Taku River Tlingit First Nation. Brixton hired Stonecroft Engineering to prepare a preliminary road access report to its main copper-gold target areas which was submitting to the land use planning process.

Foreign Countries and Political Risk: All of the mineral properties held by the Company are located in Canada, where mineral exploration and mining activities may be affected in varying degrees by changes in government regulations such as tax laws, business laws, environmental laws and mining laws, affecting the Company's business. Any changes in regulations or shifts in political conditions are beyond the control of the Company and may adversely affect its business, or if significant enough, may make it impossible to continue to operate in the country. Operations may be affected in varying degrees by government regulations with respect to restrictions on

production, price controls, foreign exchange restrictions, export controls, income taxes, expropriation of property, environmental legislation and mine safety.

Dependence Upon Others and Key Personnel: The success of the Company's operations will depend upon numerous factors, many of which are beyond the Company's control, including (i) the ability to design and carry out appropriate exploration programs on its mineral properties; (ii) the ability to produce minerals from any mineral deposits that may be located; (iii) the ability to attract and retain additional key personnel in exploration, marketing, mine development and finance; and (iv) the ability and the operating resources to develop and maintain the properties held by the Company. These and other factors will require the use of outside suppliers as well as the talents and efforts of the Company and its consultants and employees. There can be no assurance of success with any or all of these factors on which the Company's operations will depend, or that the Company will be successful in finding and retaining the necessary employees, personnel and/or consultants in order to be able to successfully carry out such activities.

Surface Rights and Access: Although the Company acquires the rights to some or all of the minerals in the ground subject to the tenures that it acquires, or has a right to acquire, in most cases it does not thereby acquire any rights to, or ownership of, the surface to the areas covered by its mineral tenures. In such cases, applicable mining laws usually provide for rights of access to the surface for the purpose of carrying on mining activities, however, the enforcement of such rights through the applicable courts can be costly and time consuming. In areas where there are no existing surface rights holders, this does not usually cause a problem, as there are no impediments to surface access. However, in areas where there are local populations or landowners, it is necessary, as a practical matter, to negotiate surface access. There can be no guarantee that, despite having the right at law to access the surface and carry-on exploration and mining activities, the Company will be able to negotiate a satisfactory agreement with any such existing landowners/occupiers for such access, and therefore it may be unable to carry out mining activities. In addition, in circumstances where such access is denied, or no agreement can be reached, the Company may need to rely on the assistance of local officials or the courts in such jurisdiction. The Company has not, to date, experienced any problems in gaining access to any of its properties.

Title Matters: Although the Company has taken steps to verify the title to the mineral properties in which it has or has a right to acquire an interest in accordance with industry standards for the current stage of exploration of such properties, these procedures do not guarantee title (whether of the Company or of any underlying vendor(s) from whom the Company may be acquiring its interest). Title to mineral properties may be subject to unregistered prior agreements or transfers, and may also be affected by undetected defects or the rights of indigenous peoples. The Company has investigated title to all of its mineral properties and, to the best of its knowledge, title to all of its properties for which titles have been issued are in good standing.

Exploration and Mining Risks: Fires, power outages, labour disruptions, flooding, explosions, cave-ins, landslides and the inability to obtain suitable or adequate machinery, equipment or labour are other risks involved in the operation of mines and the conduct of exploration programs. Substantial expenditures are required to establish reserves through drilling, to develop metallurgical processes, to develop the mining and processing facilities and infrastructure at any site chosen for mining. Although substantial benefits may be derived from the discovery of a major mineralized deposit, no assurance can be given that minerals will be discovered in sufficient quantities to justify commercial operations or that funds required for development can be obtained on a timely basis. The economics of developing mineral properties is affected by many factors including the cost of operations, variations of the grade of ore mined, fluctuations in the price of

gold or other minerals produced, costs of processing equipment and other factors such as government regulations, including regulations relating to royalties, allowable production, importing and exporting of minerals and environmental protection. In addition, the grade of mineralization ultimately mined may differ from that indicated by drilling results and such differences could be material. Short-term factors, such as the need for orderly development of ore bodies or the processing of new or different grades, may have an adverse effect on mining operations and on the results of operations. There can be no assurance that minerals recovered in small scale laboratory tests will be duplicated in large scale tests under on-site conditions or in production scale operations. Material changes in geological resources, grades, stripping ratios or recovery rates may affect the economic viability of projects.

Regulatory Requirements: The activities of the Company are subject to extensive regulations governing various matters, including environmental protection, management and use of toxic substances and explosives, management of natural resources, exploration, development of mines, production and post-closure reclamation, exports, price controls, taxation, regulations concerning business dealings with indigenous peoples, labour standards on occupational health and safety, including mine safety, and historic and cultural preservation. Failure to comply with applicable laws and regulations may result in civil or criminal fines or penalties, enforcement actions thereunder, including orders issued by regulatory or judicial authorities causing operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment, or remedial actions, any of which could result in the Company incurring significant expenditures. The Company may also be required to compensate those suffering loss or damage by reason of a breach of such laws, regulations or permitting requirements. It is also possible that future laws and regulations, or more stringent enforcement of current laws and regulations by governmental authorities, could cause additional expense, capital expenditures, restrictions on or suspension of the Company's operations and delays in the exploration and development of the Company's properties.

Limited Experience with Development-Stage Mining Operations: The Company has very limited experience in placing mineral resource properties into production, and its ability to do so will be dependent upon using the services of appropriately experienced personnel or entering into agreements with other major resource companies that can provide such expertise. There can be no assurance that the Company will have available to it the necessary expertise when and if it places its resource properties into production.

Uncertainty of Resource Estimates/Reserves: Unless otherwise indicated, mineralization figures presented in the Company's filings with securities regulatory authorities, press releases and other public statements that may be made from time to time are based upon estimates made by Company personnel and independent geologists. These estimates are imprecise and depend upon geological interpretation and statistical inferences drawn from drilling and sampling analysis, which may prove to be unreliable. There can be no assurance that:

- these estimates will be accurate;
- reserves, resource or other mineralization figures will be accurate; or
- this mineralization could be mined or processed profitably.

Because the Company has not commenced production at any of its properties, and has not defined or delineated any proven or probable reserves on any of its properties, mineralization estimates for the Company's properties may require adjustments or downward revisions based upon further exploration or development work or actual production experience. In addition, the grade of ore

ultimately mined, if any, may differ from that indicated by drilling results. There can be no assurance that minerals recovered in small-scale tests will be duplicated in large-scale tests under on-site conditions or in production scale. The resource estimates contained in the Company's filings with securities regulatory authorities, press releases and other public statements that may be made from time to time have been determined and valued based on assumed future prices, cut-off grades and operating costs that may prove to be inaccurate. Extended declines in market prices for gold, silver, copper, iron or other metals may render portions of the Company's mineralization uneconomic and result in reduced reported mineralization. Any material reductions in estimates of mineralization, or of the Company's ability to extract this mineralization, could have a material adverse effect on the Company's results of operations or financial condition. **The failure to establish additional proven or probable reserves could restrict the Company's ability to successfully implement its strategies for long-term growth.**

No Assurance of Profitability: The Company has no history of earnings and, due to the nature of its business there can be no assurance that the Company will ever be profitable. The Company has not paid dividends on its shares since incorporation and does not anticipate doing so in the foreseeable future. The only present source of funds available to the Company is from the sale of its common shares or, possibly, from the sale or optioning of a portion of its interest in its mineral properties. Even if the results of exploration are encouraging, the Company may not have sufficient funds to conduct the further exploration that may be necessary to determine whether or not a commercially mineable deposit exists. While the Company may generate additional working capital through further equity offerings or through the sale or possible syndication of its properties, there can be no assurance that any such funds will be available on favorable terms, or at all. At present, it is impossible to determine what amounts of additional funds, if any, may be required. Failure to raise such additional capital could put the continued viability of the Company at risk.

Uninsured or Uninsurable Risks: Exploration, development and mining operations involve various hazards, including environmental hazards, industrial accidents, metallurgical and other processing problems, unusual or unexpected rock formations, structural cave-ins or slides, flooding, fires, metal losses and periodic interruptions due to inclement or hazardous weather conditions. These risks could result in damage to or destruction of mineral properties, facilities or other property, personal injury, environmental damage, delays in operations, increased cost of operations, monetary losses and possible legal liability. The Company may not be able to obtain insurance to cover these risks at economically feasible premiums or at all. The Company may elect not to insure where premium costs are disproportionate to the Company's perception of the relevant risks. The payment of such insurance premiums and of such liabilities would reduce the funds available for exploration and production activities.

Enforcement of Civil Liabilities: As some of the assets of the Company and its subsidiaries were located in the United States, it may be difficult or impossible to enforce judgments granted by a court in Canada against the assets of the Company and its subsidiaries.

The Company may be a "passive foreign investment company" under the U.S. Internal Revenue Code, which may result in material adverse U.S. federal income tax consequences to investors in the Company's common shares that are U.S. taxpayers: Investors in the Company's common shares that are U.S. taxpayers should be aware that the Company expects it will in the current year be, a "passive foreign investment company" under Section 1297(a) of the U.S. Internal Revenue Code (a "PFIC"). If the Company is or becomes a PFIC, generally any gain recognized on the sale of the Company's common shares and any "excess distributions" (as specifically defined) paid on such common shares must be allocated to each day in a U.S.

taxpayer's holding period for the common shares. The amount of any such gain or excess distribution allocated to prior years of such U.S. taxpayer's holding period for the common shares generally will be subject to U.S. federal income tax at the highest tax applicable to ordinary income in each such prior year, and the U.S. taxpayer will be required to pay interest on the resulting tax liability for each such prior year, calculated as if such tax liability had been due in each such prior year.

Alternatively, a U.S. taxpayer that makes a "qualified electing fund" (a "QEF") election with respect to the Company generally will be subject to U.S. federal income tax on such U.S. taxpayer's pro rata share of the Company's "net capital gain" and "ordinary earnings" (as specifically defined and calculated under U.S. federal income tax rules), regardless of whether such amounts are actually distributed by the Company. U.S. taxpayers should be aware, however, that there can be no assurance that the Company will satisfy record keeping requirements under the QEF rules or that the Company will supply U.S. taxpayers with required information under the QEF rules, in event that the Company is a PFIC and a U.S. taxpayer wishes to make a QEF election. As a second alternative, a U.S. taxpayer may make a "mark-to-market election" if the Company is a PFIC and the Company's common shares are "marketable stock" (as specifically defined). A U.S. taxpayer that makes a mark-to-market election generally will include in gross income, for each taxable year in which the Company is a PFIC, an amount equal to the excess, if any, of (a) the fair market value of the common shares as of the close of such taxable year over (b) such U.S. taxpayer's adjusted tax basis in the common shares.

Due to the extreme complexity of the PFIC rules and the potentially materially adverse consequence to a shareholder that is a U.S. taxpayer of the Company being a PFIC, it is critical that each shareholder that is a U.S. taxpayer consult with that shareholder's U.S. tax adviser before undertaking any transactions in the Company's common shares.

Geopolitical Conflict: On February 24, 2022, Russia invaded the country of Ukraine. In addition, on October 7, 2023, armed conflict broke out between Israel and Hamas militants. This has created worldwide supply chain issues, market instability and volatility, and increased inflation. The Company cannot predict the duration or magnitude of the adverse results of this conflict and its effects on the Company's business or ability to raise funds.

Off-Balance Sheet Arrangements

The Company does not have any off-balance sheet arrangements.

Contractual Obligations

Accounting Policies and Estimates

Significant judgments are used in the Company's assessment of its ability to continue as a going concern which is described in note 1 of the consolidated financial statements. Significant accounting estimates are used in the determination of fair value and value in use for purposes of the recoverability of the carrying value of mineral properties, determination of reclamation obligations, valuation of share-based payments, and the valuation of deferred income taxes. These estimates involve considerable judgment and are, or could be, affected by significant factors that are out of the Company's control. Actual results may differ from these estimates.

Impairment

At the end of each reporting period the carrying amounts of the Company's long-lived assets, including mineral property interests, are reviewed to determine whether there is any indication that those assets are impaired. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment, if any. The recoverable amount is the higher of fair value less costs to sell and value in use. Fair value is determined as the amount that would be obtained from the sale of the asset in an arm's length transaction between knowledgeable and willing parties. In assessing value in use, the estimated future cash flows are discounted to their present value using a discount rate that reflects current market assessments of the time value of money and the risks specific to the asset.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount and the impairment loss is recognized in the profit or loss for the period. For an asset that does not generate largely independent cash inflows, the recoverable amount is determined for the cash generating unit to which the asset belongs. Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash generating unit) is increased to the revised estimate of its recoverable amount, but to an amount that does not exceed the carrying amount that would have been determined had no

impairment loss been recognized for the asset (or cash-generating unit) in prior years. A reversal of an impairment loss is recognized immediately in profit or loss.

Share-based Payments

The factors affecting share-based payments include estimates of when stock options might be exercised and the stock price volatility. The timing for exercise of options is out of the Company's control and will depend, among other things, upon a variety of factors including the market value of Company shares and financial objectives of the holders of the options. The Company has used historical data to determine volatility in accordance with Black-Scholes modeling, however future volatility is inherently uncertain and the model has its limitations. While these estimates can have a material impact on the share-based payments and hence, results of operations, there is no impact on the Company's financial condition or liquidity.

Adoption of New Standards

The Company adopted Disclosure of Accounting Policies (Amendments to IAS 1 and IFRS Practice Statement 2), and Definition of Accounting Estimates (Amendments to IAS 8) effective October 1, 2023. The adoption of these new policies did not have a material impact on the results and financial position of the Company. Please refer to Note 3 of the consolidated financial statements for the years ended September 30, 2025 and 2024.

Disclosure of Management Compensation

In accordance with the requirements of Section 19.5 of TSXV Policy 3.1, the Company provides the following disclosure with respect to the compensation of its directors and officers during the year:

1. During the year ended September 30, 2025, the Company did not enter into any standard compensation arrangements directly or indirectly with directors and officers of the Company, for their services as directors or officers, or in any other capacity, except as with Jason Shepherd. 2. During the year ended September 30, 2025, directors and officers of the Company were paid (or accrued) certain amounts, directly or indirectly, for their services as directors and officers or in any other capacity by the Company and its subsidiaries. Please refer to "Transactions with Related Parties".

Recent Developments and Outlook

The Company expects to obtain financing in the future primarily through further equity and/or debt financing. There can be no assurance that the Company will succeed in obtaining additional financing, now or in the future. Failure to raise additional financing on a timely basis could cause the Company to suspend its operation and eventually to forfeit or sell its interest in its exploration and evaluation assets.

Financial Instruments and Risk Management

IFRS 7, Financial Instruments: Disclosures ("IFRS 7") establishes a fair value hierarchy that prioritizes the inputs to the valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities.

Level 2: Quoted prices in markets that are not active, or inputs that are observable, either directly or indirectly, for substantially the full term of the asset or liability.

Level 3: Prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable (supported by little or no market activity).

The Company's cash, restricted cash, and short-term investments are classified as Level 1 of the fair value hierarchy. The carrying values of receivables and accounts payable and accrued liabilities, and due to related parties approximate their fair values due to their short terms to maturity.

Financial risk factors

The Company's risk exposures and the impact on the Company's financial instruments are summarized below:

a) Credit risk

Credit risk is the risk of loss associated with a counter party's inability to fulfill its payment obligations. The Company's receivables consist of amounts due from a Canadian government agency, and cash, restricted cash, and short-term investments are held with large and stable Canadian chartered banks. Management believes that credit risk related to these amounts is nominal.

b) Liquidity risk

The Company's approach to managing liquidity risk is to ensure that it will have sufficient liquidity to meet its liabilities as they fall due. As of September 30, 2025, the Company had cash of \$4,560,807 to settle current liabilities of \$1,361,716. The Company has sufficient cash to settle current liabilities.

c) Market risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates, and commodity and equity prices.

d) Interest rate risk

The Company has cash balances and no interest-bearing debt. The Company's current policy is to keep larger cash balances invested in investment-grade short-term deposit certificates issued by its banking institutions. The Company is nominally exposed to interest rate risk.

e) Foreign currency risk

Foreign currency risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in foreign currency rates. As at September 30, 2025, the Company had approximately US\$2,059,000 in net monetary assets denominated in US dollars. The Company has determined that a 10% increase or decrease in the US dollar against the Canadian dollar on these instruments, as at September 30, 2025, would result in approximately \$287,000 change to comprehensive loss for the year.

f) Price risk

The Company is exposed to price risk with respect to commodity and equity prices. Equity price risk is defined as the potential adverse impact on the Company's earnings due to movements in individual equity prices or general movements in the level of the stock market. Commodity price risk is defined as the potential adverse impact on earnings and economic value due to commodity price movements and volatilities. The Company closely monitors commodity prices of gold and other precious and base metals, individual equity movements, and the stock market to determine the appropriate course of action to be taken by the Company.
